



MONTHLY ACTIVITIES REPORT

-MARCH 2018-

The period of March of 2018 has been initiated by the second training at the Faculty of law UoM in Podgorica within the CABUFAL project held by Assist. prof Ksenija Grubisic, 7th March – 8th March. Dr Ksenija Grubisic, assistant professor of Sociology and Ethics at the Law School University of Zagreb. The training was organised within two working days: Afternoon session on March 7, 2018 and Morning session on March 8, 2018. The lectures followed by the discussion between the lecturer and attending professors, teaching assistants and student representatives of the Faculty of law University of Montenegro on each topic covered:

1. IMPLEMENTATION OF THE LIFELONG LEARNING PROGRAM
2. STIMULATIVE MEASURES FOR INTRODUCING COURSES ON A FOREIGN LANGUAGE

The training issues have been disseminated and discussed with several stakeholders through the following activities:

1. Lecturing before the broader audience:
 - Professors of the Law School
 - Other academic staff within the law school – teaching assistants
 - Young associates within the court
2. Consultations with the Dean of the Law School regarding the following issues:
 - i. Establishment of the Summer school with the Law School of Zagreb, schedules for June 4 - 8, 2018, “Europeanisation of the curriculum of the law school – the current status and the its perspectives”.
 - ii. Initiating the procedure on the accreditation of lifelong learning programs within Law School, University of Montenegro.
 - iii. Enhancing of the mobility students’ and professors’ mobility via: 1) Generation of the programs in English languages – electoral course, 2) Erasmus plus mobility strand programmes with Faculty of Law University of Zagreb.
 - iv. Drafting of the comparative analysis of the syllabuses of Faculty of Law, UoM and Faculty of Law, University of Zagreb.



3. Consultation with the professor of Sociology and Ethics at Law School - Assist. Prof. Marko Dokic. With regard to this report of Prof. Dokic.

4. Consultations with the project team with regard to the concrete upcoming activities: Summer school, comparative analysis of the syllabuses of Faculty of law, University of Zagreb and Faculty of Law University of Montenegro, setting up life – long learning programs, and enhancing the Mobility of students and professors.

The Project team with the project coordinator until the end of the MArch has initiated the following sub – projects which will be carefully structured during the CABUFAL lifetime. These are:

- I. Establishment of the Summer school with the Law School of Zagreb, schedules for June 4- 8, 2018, “Europeanisation of the curriculum of the law school – the current status and its perspectives”.
- II. Initiating the procedure on the accreditation of lifelong learning programs within Law School, University of Montenegro.
- III. Enhancing of the mobility students’ and professors’ mobility via: 1) Generation of the programs in English languages – electoral course, 2) Erasmus plus mobility strand programmes with Faculty of Law, University of Zagreb.
- IV. Drafting of the comparative analysis of the syllabuses of Faculty of Law, UoM and Faculty of Law, University of Zagreb.
