



MONTHLY ACTIVITIES REPORT

- November 2018 -

From the period November 1 to November 30, the entire project team has been employed on tasks relevant for the realization of the CABUFAL activities planned for the winter semester of 2018: Communication with consortium members for the organization of the activities planned in 2018: organization of the Study visit to Iustinianus Primus Law Faculty in Skopje, organization of the meeting of the Quality Control Board in London; Communication with consortium members for the organization of the activities planned in 2018; organization of the Trainings planned for the end of 2018 – Training by professors from Iustinianus Primus Faculty of law from Skopje and professors from Faculty of law University of Ljubljana; activities regarding preparation of the promotional materials for the dissemination purposes and activities regarding continual promotion of the project via project website.

Along with the current activities, three relevant events have been organized:

- 1) Training of Teachers by professors from University in Skopje Iustinianus Primus Faculty of law (November 7th to 10th, 2018);
- 2) Quality control Board meeting in London, Regents University (November, 15th to 17th, 2018);
- 3) Training of Teachers by professors from Faculty of Law University in Ljubljana (November 27th to 30th, 2018);

1. Training of Teachers by professors from University in Skopje Iustinianus Primus Faculty of law (November 7th to 10th, 2018).

A two-member delegation from the University in Skopje - Iustinianus Primus Faculty of law was staying at the Faculty of Law in the period from 7-10 November. Their trainings were realized according and the following lectures were delivered:

- Prof. dr Karolina Ristova - Aasterud- “The Position and the Functions of National Parliaments in the EU, with special Overview on the EU Enlargement Context“
- Prof. dr Jadranka Dabovikj Anastasovska - “European Consumer Law and the modalities of consumer protection from unfair contractual terms in the laws of the countries of the region: the current situation and perspectives” - „Evropsko potrošačko pravo i modaliteti zaštite potrošača od nepoštenih ugovornih klauzula u pravima zemalja regiona: sadašnje stanje i perspektive“, - na crnogorskom jeziku.

During this visit several meeting were realised: consultation with the project team; meeting with the dean of the Faculty of law University of Montenegro; consultation with the professors of the Faculty of law University of Montenegro; Consultations with the prof. dr Aneta Spaić, - on topics regarding International commercial law and EU private law, and new teaching methods and Consultations with the prof. dr Vladimir Savkovic - on topics regarding Internal market law and EU private law, and new teaching methods.

2. Quality control Board meeting in London, Regents University (November, 15th to 17th, 2018);

Quality Control Board (QCB) consisted of the representatives of all consortium partners (Aneta Spaić, Biljana Djuricin, Milan Tomic, Senka Danilovic, Vesna Simovic Zvicer, Vasilka Sancin, Masa Kovic Dine, Toni Deskoski, Petar Bacic, Mareike Frohlich) except the representative of the Law Faculty University of Zagreb. The meeting has been scheduled to determine, evaluate and assess the activities that have conducted from the day first of the CABUFAL implementation until November 15, 2018.

Quality Control System of Regent University has been the topic explored and conveyed by the representative of the Regent University - Neven Andjelic,

Project coordinator, Aneta Spaić has presented the upgraded version of the CABUFAL Quality Control Plan, which reflected the suggestions provided by the EACEA Comments on the Mid/term report such as exclusion of the all types of reports.

Along with the tools and instruments – reports, analysis, questionnaires accompanies with their analysis, linked to the CABUFAL itself. The specific CABUFAL activities have been measured accordingly.

3. Training of Teachers by professors from Faculty of Law University in Ljubljana (November 27th to 30th, 2018);

A two-member delegation from the University in Ljubljana - Faculty of law was staying at the Faculty of Law in the period from 27-30 November. Their trainings were realized according and the following lectures were delivered:
