CABUFAL TEACHER TRAINING REPORT BY VISITING PROFESSORS FROM THE FACULTY OF LAW "IUSTINIANUS PRIMUS," UNIVERSITY SS. CYRIL AND METHODIUS, SKOPJE, MACEDONIA

(7-11 November 2018)

In the period between 7-11 November, 2018, we, Prof. Dr. Jadranka Dabovic Anastasovska, Full Professor, and Prof. Dr. Karolina Ristova -Aasterud, Associate Professor, from the Faculty of Law "Iustinianus Primus" in Skopje, Macedonia, took part in the CABUFAL Teacher Training programme at the Faculty of Law in Podgorica, Montenegro. Overall, we met all the targets in the working programme that had been worked on and agreed upon since September 2018, and it is as follows:

The first day, 7 November, 2018, for the most part was a travel day, getting from Skopje to Podgorica by car. In the late afternoon and evening (6-9pm), we had our initial meeting with the project team, discussing the project in more details, as well as the activities the following days.

The second day, 8 November, 2018, from 10-12 am we had a meeting with the Dean of the Podgorica Law School, Dr. Velimir Rakochevic, presenting him with some of our research work and published books on EU-related topics, for the needs of the law school library. From noon to 2 pm, Prof. Dr. Karolina Ristova-Aasterud gave her lecture in English, titled "The Role and the Functions of the National Parliaments in the EU – Implications for the EU Enlargement." The lecture was attended by the Dean, law professors and students, not only from the law school, but also from the students in the nearby political science studies. The questions and comments were mostly focused, as expected, on the role of EU national parliaments in the Enlargement process, most specifically in the context of Macedonia and Montenegro as EU candidate countries. After the working lunch from 2-4 pm, from 4-7 pm, the visiting professor met again with the CABUFAL project team and the law school professors, having consultations and exchanging experiences regarding teaching EU-related courses, course syllabuses, as well as best teaching and exam methods regarding the courses on EU law.

The third day, 9 November, 2018, from 10 am-12 noon, the consultative meeting with the CABUFAL project team and the law school pro fessors had resumed. AT 2 pm, Prof. Dr. Jadranka Dabovic Anastasovska gave her lecture titled "EU'Consumer Protection Law and the Models of Consumer Protection against unfair contract clauses in the legal systems in the region." Her lecture was held in Montenegrin language, as it is her native language. The audience was again professors and students, but in much larger numbers from the previous days, as expected, because most students are oriented towards the (EU) private/civil law and prospective careers in legal practice. Most questions and the debate addressed the dynamics between the material and procedural law regarding consumer protection, and what needs to be done more to transposition the EU law regarding this issue in the candidate countries, primarily, again, in Macedonia and Montenegro. After the lecture, from 4.30.6.30 pm, there was another meeting with the CABUFAL team, specifically targeting the syllabuses about teaching EU consumer law.

The fourth day, 10 November, 2018, from 10-12 am, there was a joint meeting with Prof. Dr. Aneta Spaic, discussing the introduction of new teaching methods in the area of international commercial law and EU private law, followed by another meeting from 13-15 pm with Prof. Dr. Vladimir Savkovic, regarding the EU Internal Market Law and EU Private Law.

The fifth day, 11 November, 2018 was a return car trip day, back to Skopje from Podgorica.
