	Description	Guidebook/reference manual for academic and professional community on best practices in teaching and researching various aspects of EU law in Montenegro will be created, as a product of previous visits to the partner Universities, experiences of the Montenegrin professors and expertise of the consortium member's professors. This manual will be published in English and Montenegrin language, so the translating of the text will be subcontracted to the professional translators. This manual will be accessible in printed form and as well as a electronic document via a project web site which will ensure maximal dissemination.

Along with the ordinary project activities, in February of 2018, the project team with the lead of the Professor Savkovic through the several meetings and exchange of the email correspondents has generated and structured the Proposal for the project activity: "BEST PRACTICES IN TEACHING EU LAW", as follows:

**1. Number of members and structure of the Editorial Board**

Editorial Board to be consisted of 7 members:

- University of Montenegro: Associate professor Vladimir Savković and Associate professor Aneta Spaić;
- Regent University, University of Ljubljana, University of Zagreb, University of Skopje and University of Split to delegate one member each.<sup>1</sup>

**2. The list of suggested themes to be chosen by respective authors (for all authors):**

1. Institutional System of the EU;

2. Internal Market law of the EU;
3. EU competition law;
4. EU intellectual property law;
5. EU environmental law;
6. EU company law;
7. EU consumer protection law;
8. EU tax law;
9. EU criminal law
10. EU family law
11. EU private law (in general);
12. EU human rights law.

Other potential themes: EU administrative space; Judicial cooperation in EU; EU electronic commerce law; Labor and social law of the EU; EU trade policy and law (as well as other suitable themes subject to approval of the Editorial Board).

### 3. Structure of the publication (monograph):

**Part I - Teaching EU Law: Selected fields** – 10 papers: with 2 papers produced by the members of the academic staff from each of the University of Montenegro five partner academic institutions in CABUFAL project (Regent University, University of Ljubljana, University of Zagreb, University of Skopje and University of Split);

General content and structure of each of the contributions in Part I:

- a) Key legal notions and general regulatory framework for the respective field of EU law;
- b) Best teaching practices (and personal experiences) in the respective field of EU law;
- c) Conclusions – key challenges in helping the students to better understand basic notions and relation/position of the respective field of EU law within national legal systems.

**Part II – Incorporating EU Law into Montenegrin Legal System and System of Legal Education: Selected fields** (10 papers produced by the members of academic staff from the University of Montenegro Faculty of Law)

General content and structure of each of the contributions in Part II:

- a) Incorporating the respective field of EU law into Montenegrin legal system – current state, challenges and perspectives;
- b) Teaching the respective field of EU law and challenges in adjusting accordingly the University of Montenegro Faculty of Law curriculum.

### 4. Time frame



- a) Authors to be designated by June 10, 2018;
- b) Manuscripts to be submitted to Editorial Board by November 30, 2018;
- c) Manuscripts to be reviewed by the Editorial Board by December 31, 2018;
- d) Manuscripts (if necessary) to be revised by authors by February 28, 2019;
- e) Needed translations, copy-editing, proofreading and other relevant publication formalities (including the printing) to be finalized by May 31, 2019.
